3. What Information We Collect

We may collect personal information including:

- Full name
- Date of birth
- Address
- Email address
- Phone number

We may also collect sensitive health information including:

- Medical history
- Current symptoms and health concerns
- Medications and supplements
- Pathology and diagnostic test results
- Lifestyle and dietary information
- Family health history
- Practitioner clinical notes and treatment plans

For patients under 18 years of age, we collect information from a parent or legal guardian.

4. How We Collect Information

We collect personal information directly from you through:

- Initial intake forms
- Health questionnaires
- Telehealth consultations
- Email correspondence
- Test results provided by you
- Information provided by other healthcare practitioners (with your consent)

We may also receive information from third parties where you have authorised disclosure.

5. Why We Collect Your Information

We collect your information to:

- Provide herbal medicine and integrative health services
- Assess and manage your health concerns
- Develop individualised treatment plans
- Arrange pathology and functional testing
- Recommend supplements and therapeutic products

- Communicate with you regarding appointments and treatment
 - Maintain accurate clinical records
 - Meet legal and professional obligations

6. Disclosure of Information

Your personal and health information is treated as confidential and will not be disclosed without your consent, except where required or authorised by law.

With your consent, we may disclose information to:

- General practitioners
- Medical specialists
- Allied health practitioners
- Pathology laboratories
- Functional testing providers
- Supplement and dispensary services

Including (but not limited to):

- Nutripath
- Microba
- Australian Clinical Labs
- Instant Scripts
- Vital.ly
- Natural Scripts

Only information necessary for your care will be shared.

7. Telehealth Services

Pure Health Integrative Practice operates primarily via telehealth consultations.

Telehealth consultations are conducted using Zoom or other secure communication platforms.

While reasonable steps are taken to protect your information, electronic communication and online consultations carry inherent risks outside of our control.

By participating in telehealth consultations, you acknowledge and accept these risks and agree to attend consultations from a private and secure environment where possible.

8. Storage and Security of Information

We take reasonable steps to protect your personal information from misuse, interference, loss, unauthorised access, modification, or disclosure.

Patient records are stored electronically on password-protected systems and may be backed up using secure cloud-based storage services, including Microsoft OneDrive.

Access to patient records is restricted to authorised personnel only (sole practitioner access).

While we implement strong security measures, no electronic system is completely secure, and we cannot guarantee absolute protection of information transmitted or stored digitally.

9. Appointment Reminders and Communication

We may contact you via email regarding:

- Appointment confirmations and reminders
- Clinical follow-up information
- Test requests and results
- Administrative or treatment-related communication

You may request changes to your communication preferences at any time.

10. Website Privacy and Cookies

When you visit our website, we may collect basic technical information such as:

- IP address
- Browser type
- Device information
- Pages visited and website usage data

This information is used to improve website performance and user experience.

Our website may use cookies or similar technologies. You can disable cookies through your browser settings if preferred.

11. Access and Correction

You may request access to the personal information we hold about you.

If you believe your information is inaccurate, incomplete, or outdated, you may request correction.

We will respond within a reasonable timeframe in accordance with Australian law.

12. Retention of Records

We retain patient records in accordance with legal and professional requirements.

Generally:

- Adult records are retained for a minimum of 7 years from the last consultation
 - Records for children are retained until the patient reaches adulthood plus the required retention period
